
**Sub:** **Implementation of the Telecommunications Right of Way Rules (RoW), 2024.**

**Ref:** Letter received from the Secretary, DoT, Govt. of India, New Delhi vide  
D.O. letter No. 5-6/2024(186123), DT: 11.11.2024 (copy enclosed)

In the reference, the Secretary, Department of Telecommunications (DoT), Government of India (Gol) informed that "... the DoT has recently notified the Telecommunications Right of Way Rules (RoW), 2024 in accordance with the Telecommunications Act, 2023. Further, it was informed that the Telecommunications RoW Rules, 2024 are now mandatorily to be followed by States without any need for going through adoption process and the said Rules would stand implemented w.e.f. 01.01.2025".

Hence, it is to inform that from 01.01.2025, the existing Himachal Pradesh Right of Way (RoW) Policy, 2023 issued vide Notification No. DIT-F/21/2021-(e-34214)-302 dated:31.01.2024, shall cease to exist.

The Telecommunications Right of Way Rules (RoW), 2024 in accordance with the Telecommunications Act, 2023 notified by the Gol shall come into effect from 01.01.2025 in the State of Himachal Pradesh, initially for a period of one year. Necessary instructions shall be issued to the heads of the department, autonomous organizations, and subordinate units under the Departments of the Government of Himachal Pradesh to follow and comply with the rules.


